School Choice Guidelines

The School Choice Program allows a parent to enroll their child in a school district that is not the child's home district. Because of space limitations, not all school districts participate in the School Choice program. Yearly, the Westfield School Committee decides whether it will accept new enrollments under this program.

As a parent of a student applying to the School Choice Program, I understand and agree to the following guidelines:

- 1. An application is required for each student applying.
- 2. Applications from siblings of students currently in the School Choice program will receive preference in the admissions lottery.
- 3. If more students apply than there are spaces available, a lottery will be held to select the students that will be admitted.
- 4. Your child may be denied a School Choice seat based on past school disciplinary actions in accordance with Massachusetts General Laws.
- 5. Bus transportation is **not** available for School Choice students.
- 6. Once accepted into the School Choice Program, parents will need to complete the registration process by contacting the school directly and make an appointment for registration.
